Norfolk County Council (NCC) County Councillor Roper reported that Norfolk Council have gone back on their decision not to close the Mayton Wood Recycling centre, it is reported that the closure would save £70,000. This has gone against what residents wanted there is now a petition taking place to keep the centre. open. Budget is due to take place in 2 weeks looking at a 4.99% tax increase. Consultation process out for green light devolution.

Broadland District Council (BDC) District Councillor Sue Holland reported that BDC are not increasing council tax for Broadland residents this year. Broadland staff are now starting to move into the new horizons building.
