Norfolk County Council (NCC) County Councillor Roper sent a report to the clerk in his absence.

Broadland District Council (BDC) District Councillor Sue Holland provided an update on Nutrient Neutrality, Broadland District Council are going to link up with other District Councils, developers will be able to buy credits in return for mitigation. The council could not approve plans involving 'overnight accommodation' until it could be proven they would not pollute waterways. Councillor Vincent commented that neutrality is a good way of making use of land not being used to create wildlife areas.

Budget consultation is now taking place.
