Councillor Roper reported that Norfolk County Council will not look at a pedestrian refuge on the North Walsham Road junction with Crostwick Lane due to the speed limit, Mr Roper will still explore this to see if there is scope to reduce the speed limit. I was reported that there is the option of installing a Vehicle Activated Sign (VAS) on the North Walsham Road to warn traffic to slow down and to install clearer 'Spixworth' direction signs at the junction.

Westcotec are looking to repair the VAS signs located near the church and car garage on Buxton Road.
